PARCEL "A"

The North half of the Northwest quarter of the Northeast quarter of Section 25, Township 26 North, Range 5 East, W.M., in King County Washington; EXCEPT the West 30 feet thereof conveyed to King County for Right-of-Way for Manny Road (known also as 172nd Avenue Northeast) by deed recorded under Auditor's File No. 2754997.

PARCEL "B"

The Southeast quarter of the Southeast quarter; EXCEPT the North 90 feet and the East 30 feet; and The East half of the Southwest quarter of the Southeast quarter, all in Section 24, Township 26 North, Range 5, East, W.M., in King County.

RESTRICTIONS

No lot or portion of a lot in this plat shall be divided and sold or resold or ownership changed or transferred whereby the ownership of any portion of this plat shall be less than the area required for the use district in which located.

Prior approval must be obtained from the Department of Public Works before any structure, fill or obstructions, including fences, are located within any drainage easement or delineated flood plain area.








BASES OF BEARINGS




